INVITATION OF BID

1. SCOPE OF WORK: -

“Supply, Delivery, Assembly, Installation and Operationalization of various Agricultural tool/equipment and Agro processing machinery/equipment for “Chhaygaon Agro Cluster”.

2. Estimated Amount is **Rs. 8,717,500/-**

2. ELIGIBILITY CRITERIA OF THE BIDDER: -

- a) The bidder must have successfully completed similar nature of works during last five years.
- b) The bidder must have successfully completed three similar works.
- c) The Supplier should be able to provide post sales service and support for at least 2 years from successful completion of work.

3. COMMERCIAL ELIGIBILITY CRITERIA OF THE BIDDER: -

- a) Average annual turnover during last three years must be **Rs. 3,487,000/-** (40% of the Tender Amount)

4. OTHER STATUTORY REQUIREMENTS (Essential): -

The Bidder shall furnish the following documents

- a. EPF registration
- b. ESIC registration
- c. PAN Card detail
- d. I.T Return for last three financial years
- e. GST Registration Certificate; GSTIN
- f. Professional Tax Paid Certificate
- g. Performance as prime contractor for execution of similar nature of work for last five years and details of works in hand

5. The concerned bidder/ supplier should mandatorily provide their **Postal Address, Email Id** and **Contact Number** in their forwarding letter (Annexure I). For urgent communications, notice and correspondence in regard to the tender processes the email Id will be used and therefore a functional official email Id should be provided. Any communications/notices served through the provided email ID from competent authority will be treated as integral part of the tender process.

6. Estimated Amount is **Rs. 8,717,500/-**

7. Earnest Money Deposit amounting to **Rs. 174,350/- (One Lakh Seventy-Four Thousand Three Hundred Fifty Only, i.e. 2% of total estimated amount)** for general/ OBC and **Rs. 87,175/- (Eighty-Seven Thousand One Hundred Seventy-Five Only, i.e. 1% of total estimated amount)** for SC/ST shall be submitted individually in favor of “Chhaygaon Agro Cluster” and in the form of demand draft payable at Guwahati along with the bid.

8. Any bidder against whom FIR/Complaint is lodged with Police will not be eligible to participate in the bidding process.

9. Price quoted will be inclusive of GST, freight/transportation, taxes, charges, duty, transit insurance and installation and operationalization.

10. Period of delivery and installation: 60 working days from the date of acceptance of the work order.

11. The Competent Authority reserves the right to reject all or any tender wholly or partly without assigning any reason whatsoever.

14. The tender should be submitted in accordance with the instructions and conditions and any tender not conforming thereto is liable to be rejected. The instruction shall form the part of the tender and contact. The tender shall be complete with all documents. The tender received without tender fee shall be rejected outright.

15. The tender fee amounting to Rs. 1500/- in the form of demand draft should be submitted individually in favor of “**Chhaygaon Agro Cluster**” payable at Guwahati.

16. The tender documents (technical bid and financial bid) are to be separately spiral bound in order to maintain the integrity and authenticity of the documents. The bidder or his official designate must sign in every pages of the documents with their official stamp. INSTRUCTION TO BIDDERS

1. Submission of Tenders:

Tenders are to be submitted offline. All the documents uploaded by the Tender Inviting Authority form an integral part of the Contract. Tenderers are required to submit all the tender documents along with the other documents, as asked for in the **INVITATION OF BID** published in the website mentioned above and within the stipulated date and time as given in the Tender Notice.

Eligibility of the supplier:

1. Must have at least 3 years of experience of supplying such items (related Agro-Processing Machines and Equipment)
2. Must have at least **Rs. 3,487,000/-** of annual turnover from the supply business. (40% of the estimated price), as reflected in its CA audited statements of the previous years.
3. Must not be black listed by any agency from supplying of such items in the five years.
4. Must have experience of capability of providing on site services/post sales services.
5. Failure to submit any of the given documents will render the bidder liable to be rejected for techno-commercial bid.
6. Bids failed in the stage of technical bid will not be considered for financial bid.

III. Packing, transportation and installation of the Machines:

The successful bidder is liable to supply as per the prescribed specifications only and also shall be responsible for packing, transportation; installation & operationalization and trial run of the machineries and equipment as given below:

- a) The agency has to pack and transport the machines to the CFC location at Chhaygaon Agro Cluster, Alegjari, Kamrup District, Assam- 781124
- b) The agency shall install, demonstrate and carry out a trail run of the machines at the Chhaygaon Agro Cluster, Alegjari, Kamrup District, Assam- 781124
- i) **TRAINING:** The bidder should impart suitable training to a group of cluster artisans for operation and maintenance of the machines at the cluster site.
- ii) **SPARES:** The agency has to provide required spare parts as and when required for at least 2 year as per the market price. The present market price of the spare part shall be mentioned along with the quotation.
- iii) **SERVICES:** The supplier either need to have local technical service providers for repairing and maintenance or should have trained technicians in the district where the cluster is located and need to provide an undertaking/ guarantee in judicial stamp paper indicating ability to provide the repairing or maintenance services for three years at free of cost.
- iv) **MRLS & MANUALS:** The supplier has to include manufacturer recommended list of spares & cost thereof for 2 years successful running of machine in their quotation. However, the same will not be considered for finalization of order.
- v) **GUARANTEE:** Supplier should give Bank guarantee 10% of quoted amount valid for a period of one year from the date of receipt of the work order. The guarantee would be released subject to

satisfactory performance of machineries and equipment as per manufacturer's guarantee and warrantee terms and conditions for machineries and equipment and established industry standards as applicable. The period of validity of guarantee and warrantee should count from the date of handover of the ordered equipment, machineries to the buyer followed by successful installation, commissioning, test run and training of operator designated by the buyer of the machines.

vi) VALIDITY: The validity for the supply of machineries will be two months (60 days) from the receipt of the work order from **Grameen Sahara**.

vii) PAYMENT: 1st 50% installment at the time of supply order and submitting the Bank Guarantee and 2nd 50% installment after final installations, assembling, commissioning, operationalization, test run, training of operator in the CFC location of the Cluster. The bank guarantee may be increased by the competent authority considering the techno-commercial credibility and the same will be specified in the work order. The amount of bank guarantee would be specified in the work order.
